

**TOWN OF SUPERIOR (“Town”) FAIRVIEW CEMETERY
RULES & REGULATIONS**

- A. The dimension of an individual cemetery space shall be five (5) feet in width and ten (10) feet in length (unless otherwise designated by the Town). Each space shall be paid in full in advance, based upon the current fee schedule.
- B. Purchaser understands and agrees that the Town is not responsible for the actions of any mortuary, and all interment procedures and costs are the responsibility of the Purchaser.
- C. The Town, its agents and assigns, reserves all rights of ingress and egress over cemetery spaces and agrees to use reasonable care while exercising these rights and shall, if responsible, repair any and all damages caused by the Town, its agents and assigns.
- D. Cemetery hours of operation: sunrise to sunset, 7 days a week.
- E. Cemetery closed for rain except for services.
- F. All traffic must stay on established roadways.
- G. Blue hose bibs designate fresh water.
- H. DO NOT** place dirt or rock in garbage cans.
- I. Place large piles of brush or weeds next to main roadways for pick-up.
- J. The Town reserves the right to remove decorations and flowers that are deemed to be unsightly or weathered, or that interfere with ground maintenance.

INTERMENT GUIDELINES

- A. An Arizona State Disposal-Transit Permit must be presented to the Town staff at the time of interment(s) (State Regulation Section R-9-19361, Chapter 19, State Vital Records and Statues). This Permit is acquired through a mortuary.
- B. Every space with an interment must be clearly marked with the full name of the interred.
- C. Cremation Urns may be interred in a single adult grave with the maximum of four (4) cremains per grave. An urn container is required for all inurnments.
- D. Forty-eight (48) hours notice (two working days—Monday through Friday) is required to prepare a grave site.
- E. Fees for Open/Close Fees may not be prepaid, are based upon the current fee schedule, and shall be paid in full prior to interment.
- F. Spaces are for the use of the Purchaser, Purchaser’s designee (“Owner”) as shown on the front, or immediate family only; and only the Purchaser, or Purchaser’s legal representative, may designate use of the purchased space.

DECORATIONS

- A. The Town is not responsible for any damage or loss of any plants, vegetation, ornaments or decorations left at the gravesite.
- B. No trees may be planted on or around a gravesite.
- C. Benches, monuments or other types of ornamentation **MAY NOT** project past the five (5) foot by ten (10) foot gravesite or shall they be higher than five (5) feet.
- D. A work permit and deposit, based upon the current fee schedule **IS REQUIRED** in advance for any curbing, borders and caps.
- E. Landscaping must be limited to non-deciduous, native Arizona shrubs and perennials.
